## TIER I CANADA RESEARCH CHAIR IN AGRICULTURAL, FOOD OR NUTRITIONAL SCIENCE (Associate Professor / Professor)

The Faculty of Land and Food Systems (<a href="https://www.landfood.ubc.ca">https://www.landfood.ubc.ca</a>) at The University of British Columbia (Vancouver campus) invites applications from outstanding investigators for a Tier I Canada Research Chair in Agricultural, Food or Nutritional Science. The successful candidate will be appointed at the rank of Associate Professor or Professor (with tenure). The anticipated start date is September 1, 2022.

Candidates will have established an internationally recognized research program in one of the following areas: 1) climate change and resilient food systems; 2) nutrition and food security; 3) sustainable agriculture or; 4) the health and welfare of animals in society. The successful candidate will develop a program appropriate for support under the umbrella of the Natural Sciences and Engineering Research Council of Canada (<a href="https://www.nserc-crsng.gc.ca/Index\_eng.asp">https://www.nserc-crsng.gc.ca/Index\_eng.asp</a>). The Chair's research program will attract substantial new funding from national and international agencies, and support collaborations and build bridges across the Faculty of Land and Food Systems, and across UBC and the international research community.

Nominees for Tier 1 CRC positions must be Professors, or Associate Professors who are expected to be promoted to the Professor rank within one or two years of the nomination. The Canada Research Chairs Program supports outstanding researchers in areas that will further UBC's strategic research plan. All Chair nominations are subject to review and final approval by the CRC Secretariat. The Faculty of Land and Food Systems (LFS) is a recognized leader in sustainable agriculture; food, nutrition and health; and food safety and quality. Our scientists have informed and influenced policy related to food insecurity, animal welfare, and climate change from agriculture. LFS currently consists of 54 faculty members and 111 full time staff with an enrolment of 1781 undergraduate students and 226 graduate students. Core areas of expertise and training include Applied Animal Biology, Food Science, Human Nutrition, Integrated Studies in Land and Food Systems, Plant Science, and Soil Science. The Faculty operates the Centre for Sustainable Food Systems at UBC Farm, the Dairy Education and Research Centre in Agassiz, B.C., and the Wine Research Centre at UBC Okanagan and UBC Vancouver.

Applicants should submit a cover letter, a curriculum vitae, a detailed summary of research interests describing funded projects and future directions (maximum 5 pages), a statement of how you will build a collaborative program within the LFS, and a statement describing your experience working with a diverse student body, as well as your past, present, and/or future contributions to creating/advancing a culture of equity and inclusion.

The information you provide will only be used to determine whether you qualify for participation in this hiring process. Data will be collected by the Equity & Inclusion Office and only the names of those who identify as women, visible minorities (member of groups that are racially categorized) and/or Indigenous peoples will be shared with the search committee. BC welcomes and encourages applications from people with disabilities.

Equity and diversity are essential to academic excellence. An open and diverse community fosters the inclusion of voices that have been underrepresented or discouraged.
