Assistant Professor (Tenure Track) or Associate Professor (Tenure), Tier 2 Canada Research Chair | Division of Endocrinology and Metabolism, Department of Medicine, UBC Vancouver Campus Department of Biology, UBC Okanagan Campus

The Division of Endocrinology and Metabolism, Department of Medicine and the Department of Biology at The University of British Columbia (UBC) invite applications for a Tier 2 Canada Research Chair (CRC) in Nutrition and Chronic Disease Prevention and Management. The successful candidate will be eligible to hold an appointment at the rank of Assistant Professor (tenure track) or Associate Professor (with tenure). The successful candidate will have a primary academic faculty appointment in the Division of Endocrinology and Metabolism, Department of Medicine, Faculty of Medicine and a joint academic faculty appointment in the Department of Biology, Faculty of Science, UBC Okanagan Campus, as well as an Investigator appointment within the Faculty of Medicine's Centre for Chronic Disease Prevention and Management (CCDPM). The position will be located at the UBC Okanagan Campus.

Department of Medicine, UBC Vancouver Campus

The UBC Department of Medicine provides excellence in research, teaching and clinical services related to the nature, cause and prevention of adult diseases. We are the largest Department in the Faculty of Medicine with over 1,200 faculty and staff. The Department is comprised of 18 divisions with faculty located throughout the Province of British Columbia. The UBC Department of Medicine is committed to ensuring the success of our learners and faculty, and to contributing to the health of the Province of British Columbia.

Department of Biology, UBC Okanagan Campus

The Department of Biology at UBC's Okanagan campus has over 100 faculty and graduate students engaged in research, including a cluster focused on microbiota and inflammatory disease. The Department is also home to approximately 800 undergraduates in five different majors, including Biology, Biochemistry, and Microbiology. Research and teaching are supported by access to advanced infrastructure including an animal care facility (for mouse *in vivo* experimentation), a DNA sequencing core facility, extensive microscopy resources, and expertise in glycoanalytical chemistry.

As a faculty member within the Department of Medicine and the Department of Biology and an Investigator in the CCDPM, the successful candidate will be expected to lead a strong, innovative, and internationally recognized research program in Nutrition and Chronic Disease Prevention and Management. As the Chairholder and as part of a multidisciplinary research team, the successful candidate will be engaged in:

- Clinical trials of the use of nutritional interventions to address outcomes related to chronic disease prevention and/or management, particularly cardiometabolic health (e.g., obesity, Type 2 diabetes)
- Research that engages members of Indigenous and rural/remote communities.
- Research that will have a direct impact on the lives of people living in the Okanagan Valley and beyond.
- Becoming a regional and national leader in nutritional interventions to prevent or manage chronic conditions.

The appointee will also be expected to participate in the teaching activities of the Department of Medicine and Department of Biology within the <u>Southern Medical Program</u> as well as provide mentorship and training

to undergraduate, graduate, and postgraduate learners. The appointee will report to the Department Heads of Medicine and Biology and to the Regional Associate Dean, Interior.

The successful candidate will hold a PhD in nutritional science or a related discipline. Special consideration will be given to applicants who are also Registered Dietitians. The successful candidate will have an established program of research on nutrition as it applies to chronic disease prevention and/or management and a proven ability to attract external funding. If appointed at the rank of Assistant Professor, the successful candidate will have demonstrated evidence of ability in teaching, evidence of ability in scholarly activity, and will be expected to provide service to the University and the broader academic and professional community. If appointed at the rank of Associate Professor, the successful candidate will have demonstrated evidence of successful teaching and ability to direct graduate students, evidence of sustained and productive scholarly activity, and must be willing to participate in the affairs of the Department and the University. The successful candidate will have demonstrated ability to effectively communicate and interact with empathy, understanding and, respect of diverse and divergent perspectives and behaviours.

Applicants must meet the eligibility requirement for a Tier 2 CRC position. Tier 2 Chairs are intended for exceptional emerging scholars (i.e., candidates must have been an active researcher in their field for fewer than 10 years at the time of nomination). Applicants who are more than 10 years from having earned their highest degree (and where career breaks exist, such as maternity, parental or extended sick leave, clinical training, etc.) may have their eligibility for a Tier 2 Chair assessed through the program's Tier 2 justification process. Nominations are subject to review by the CRC Secretariat, and appointment as a CRC is conditional upon their approval. Salary will be commensurate with qualifications and experience. The anticipated start date for this position is July 1, 2021 or upon a date to be mutually agreed. Review of applications will begin on February 15, 2021 and continue until the position is filled.

In assessing applications, UBC recognizes the legitimate impact that leaves (e.g., maternity leave, leave due to illness) can have on a candidate's record of research achievement. These leaves will be taken into careful consideration during the assessment process.

In accordance with UBC's CRC Equity, Diversity, & Inclusion Action Plan, and pursuant to Section 42 of the BC Human Rights code, the selection will be restricted to members of the following designated groups: women, visible minorities (members of groups that are racially categorized), persons with disabilities, and Indigenous peoples. Applicants to Canada Research Chair positions are asked to complete the equity survey (https://ubc.ca1.qualtrics.com/jfe/form/SV 6WJHol7SfPxRMu9) as part of the application, and candidates from these groups must self-identify as belonging to one or more of the designated equity groups to be considered for the position. Because the search is limited to those self-identifying as members of designated equity groups, candidates must also provide their name to be considered.

The information you provide will only be used to determine whether you qualify for participation in this hiring process. Data will be collected by the Equity & Inclusion Office and only the names of those who identify as women, visible minorities (member of groups that are racially categorized) and/or Indigenous peoples will be shared with the search committee. Currently, UBC has a gap in representation for people with disabilities.
