## Assistant Professor (tenure track) Canada Research Chair (CIHR, Tier II) in Nutritional Epidemiology

The Faculty of Land and Food Systems (LFS) at the University of British Columbia (Vancouver campus) (<a href="www.landfood.ubc.ca">www.landfood.ubc.ca</a>) is currently accepting internal applications from outstanding researchers with a current full time faculty appointment in LFS at the rank of Assistant Professor (tenure track) for a Canada Research Chair (CIHR, Tier II) in Nutritional Epidemiology. This position will be part of the Human Nutrition (HUNU) group in the Food, Nutrition and Health Program. The anticipated start date is September 1, 2020.

Candidates must hold a Ph.D. in Epidemiology, Human Nutrition, or Nutritional Epidemiology, awarded within the past 10 years. Applicants should have a very strong scholarly record, comprising high quality publications in leading journals, and demonstration of an early track record of success in graduate student recruitment and supervision, teaching, and obtaining funding from multiple granting agencies that ideally includes a diverse set of national and international collaborators. The successful applicant will have experience in investigating the links between diet and certain non-communicable chronic diseases (NCD), such as cardiovascular disease (CVD), diabetes and some cancers. The successful candidate will work to address a major gap in this research by providing a comprehensive evidence-base for informing future developments of national nutritional policies in Canada, with a particular focus on reducing the diet-related burden on NCD.

Nominees for Tier 2 Chair positions must be emerging scholars no more than 10 years from their highest degree at the time of nomination. Applicants with more than 10 years owing to legitimate career interruptions (maternity, parental, or extended sick leave, clinical training, etc.) may have their eligibility for a Tier 2 chair assessed through the CRC program's Tier 2 justification process which involves submission of a Tier 2 Justification Assessment form to the Tri-Agency Institutional Programs Secretariat. Consistent with the core areas of strategic strength in LFS, the successful candidate will strengthen the position of LFS position as a leader in integrated research that addresses critical issues related to human health, a sustainable food supply and the responsible use of finite land and water resources. The successful applicant will help LFS enhance its standing as a leader the area of developing data infrastructure resources used to ascertain the dietary patterns of Canadians. In particular, the successful applicant will focus on the development and use of multivariable and predictive algorithms to measure the disease burden associated with dietary choices.

Faculty members in the HUNU Group conduct research that shapes fundamental nutrition knowledge, clinical practice, educational pedagogy, and public health approaches to Nutrition. HUNU engages with a diverse group of stakeholders including local, national, and international health care providers and governments on such topics as school food policies, community food programs, nutritional screening and interventions, international nutrition interventions and global nutrition policies.

Applicants should provide a 1) two-page cover letter; 2) detailed curriculum vitae; 3) names and contact information of three references, 4) five-year research plan (1-2 pages) to Dr. David Kitts, Associate Dean Research at david.kitts@ubc.ca by February 15, 2020.
